**FORTRESS GLOBAL ENTERPRISES REMINDS DEBENTUREHOLDERS TO VOTE  
BEFORE THE CONSENT FEE DEADLINE**

**Vancouver, British Columbia, September 20, 2018**

Fortress Global Enterprises Inc. ("**Fortress Global**" or the "**Company**") (TSX: FGE) (OTCQX: FTPLF) would like to remind holders (the "**Debentureholders**") of its 7.0% convertible unsecured subordinated debentures due December 31, 2019 (the "**Debentures**") (TSX: FGE.DB.A) that they have until 5:00 p.m. (Vancouver time) on Monday, September 24, 2018 (the "**Consent Deadline**") to vote in favour of the extraordinary resolution to approve the proposed Debenture amendments (the "**Amendments**") to be eligible to receive a consent fee equal to 2% of the principal amount of Debentures held by such Debentureholders as at the record date for the meeting of Debentureholders to be held on October 1, 2018 (the "**Meeting**").

**Debentureholders that do not vote in favour of the Amendments by the Consent Deadline will not be eligible to receive the consent fee, but will be bound by the Amendments if they become effective.**

**INDEPENDENT PROXY ADVISOR RECOMMENDS A VOTE IN FAVOUR**

Leading independent proxy advisory firm, Glass Lewis & Co., LLC, has recommended that Debentureholders vote **FOR** the Amendments at the Meeting.

**INDEPENDENT FAIRNESS OPINION**

Acumen Capital Finance Partners Limited has provided the special committee of the Company's board of directors with an independent opinion that, as of the date of such opinion, the Amendments are fair, from a financial point of view, to the Debentureholders.

**BOARD OF DIRECTORS RECOMMENDS A VOTE IN FAVOUR**

For the reasons described in the management information circular of Fortress Global in relation to the Meeting dated August 28, 2018 (the "**Circular**"), and summarized in the Company's news release dated August 28, 2018, the Company's board of directors **UNANIMOUSLY RECOMMENDS** that Debentureholders vote **FOR** the Amendments.
